At its Meeting for Business held on Sunday May 18, 2014 the Saranac Lake Monthly Meeting of the Religious Society of Friends approved the following minute:

The Assistant Clerk read a message from the Yearly Meeting's Earthcare Working Group asking for action with regard to climate change. The Meeting wishes to convey the following thoughts to the Working Group:

1. Friends are urged to read the recently published *Summary for Policymakers* from the Intergovernmental Panel on Climate Change and to share that information (Google "climate change report".

2. Friends schools should be urged to teach around climate change issues.

3. The Working Group could make suggestions for specific tasks we could undertake as individuals and Meetings.

4. We would appreciate suggestions from the Working Group as to uniquely Quaker viewpoints/ideas/techniques which would be valuable as we work on this issue.

5. The Meeting urges the Working Group to continue efforts to make this a priority for the Priorities Working Group at Yearly Meeting Summer Sessions this July. This concludes the minute.

The following was placed in our monthly newsletter. It was based on what I understood from your emails:

EARTHCARE, AS A PRIORITY

On June 8, after worship, a discussion of our role as Friends in moving our species towards a positive relationship with creation is planned. The Earthcare Working Group of the New York Yearly Meeting has asked all the meetings to consider what we believe, as individuals and as communities, are the complex factors affecting the earth's ecology and how we Friends could direct our activities. We are asked to meet and draft a statement to send to them. They are planning it as a presentation at this year's Silver Bay Summer Sessions. Their hope is to "infuse" all of our priorities with a concern for the crisis that our planet is experiencing, particularly noting climate change.

Paraphrasing, slightly, from an e-mail received: "Monthly Meetings are currently contemplating: 1) How important is the Earth; specifically rapidly accelerating climate change and extreme weather as a concern? 2) How, and to what degree do Friends want to engage with these issues personally and as Meetings? 3) How does, or ideally, how might the pervasive impact of climate change constructively shape the NYYM priorities-'framework'?"

At our last worship with a concern for business, the community decided to try to meet their request, hence the meeting on June 8. We hope that enough of us will attend and represent a creative and broad range of thought on our role. If you cannot attend that day, please consider writing a simple statement of your concern and ideas and send it to me, Mary Ann, who is acting as convener for the meeting. Do not let the questions quoted above limit your thinking about the role of Friends. Consider the relationship of our environment to our values of simplicity, integrity, equality, peace, community. What would be the most effective focus of action as individual and a community....what can we actually achieve? Etc.

The NYYM Earthcare group describes itself as a" network of Quaker Friends throughout NY taking spirit-led action grounded in Quaker testimony, to preserve, protect and live lightly on the Earth."
