**NYYM Other Funds** At the 2016 Fall Sessions, the Body approved using the 2016 excess of revenue over expenses as income for the 2017 budget. Primarily because no audit was undertaken in 2016, there was a substantial excess - \$36,000. The 2017 budget included \$13,950 of this excess as revenue. However the revised budget for 2017 has an excess of revenue over expenses, including the \$13,950, of \$8,815. This is reflected in the 9/30/17 Operating Reserve Balance of \$256,000. Three months of budgeted 2018 Operating Expenses is \$182,000. Therefore have an excess of \$74,000, approximately ½ of which is budgeted for 2018
